PILOT PLANT TECHNOLOGIST

What do we expect of you?

As a Process Plant Technologist you are part of the department Process Optimization and Implementation (POI). Key responsibilities of POI are the delivery of equipment, the optimization of processes in terms of capacity, yield, efficiency and quality consistency and the implementation of processes in production. Both the optimization of processes and the development of new products is supported by pilot plant trials. The pilot plant facility is operated by POI. You work together with colleagues from Production, Product R&D, raw material suppliers and Quality. You report to the Pilot Plant Manager. The department and the pilot plant are based in Mierlo (NL) and delivers services for all GNT's production facilities.

What do we expect from you?

As Process Plant Technologist, you cover a broad range of responsibilities:

- You perform R&D for trouble shooting, process optimization and product development on laboratory and pilot scale.
- You define, prepare and execute test trials, analyze the obtained samples, evaluate the results and take care of documentation. You work both individually and in a team.
- You work includes activities like optimizing the settings of a specific unit operation; screening of
 membranes, enzymes, process aids or ingredients; investigating alternative process equipment
 or technologies; support with troubleshooting performance or quality issues in production;
 exploring the options for rework of off-spec batches; or complete processing from raw material
 to concentrate for sorts screening of raw materials, raw material troubleshooting or new raw
 materials.
- You support with the implementation of new or improved production processes in production lines.
- You think along in improving the pilot plant facility.
