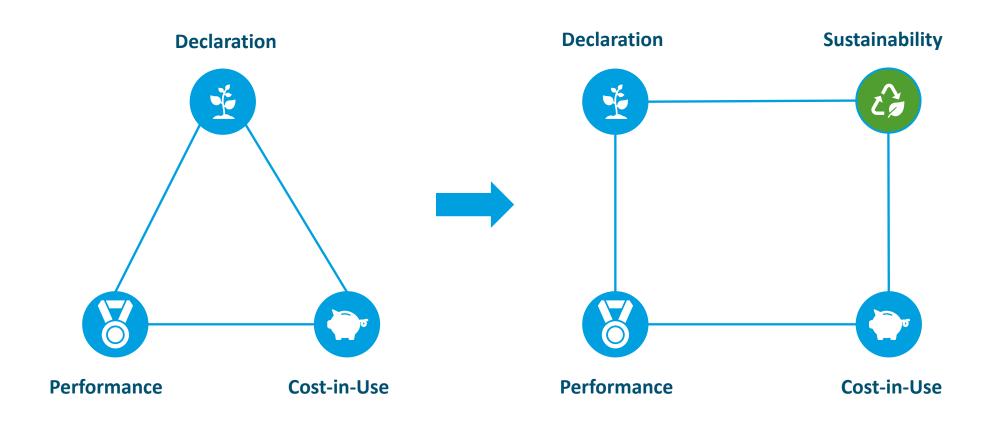

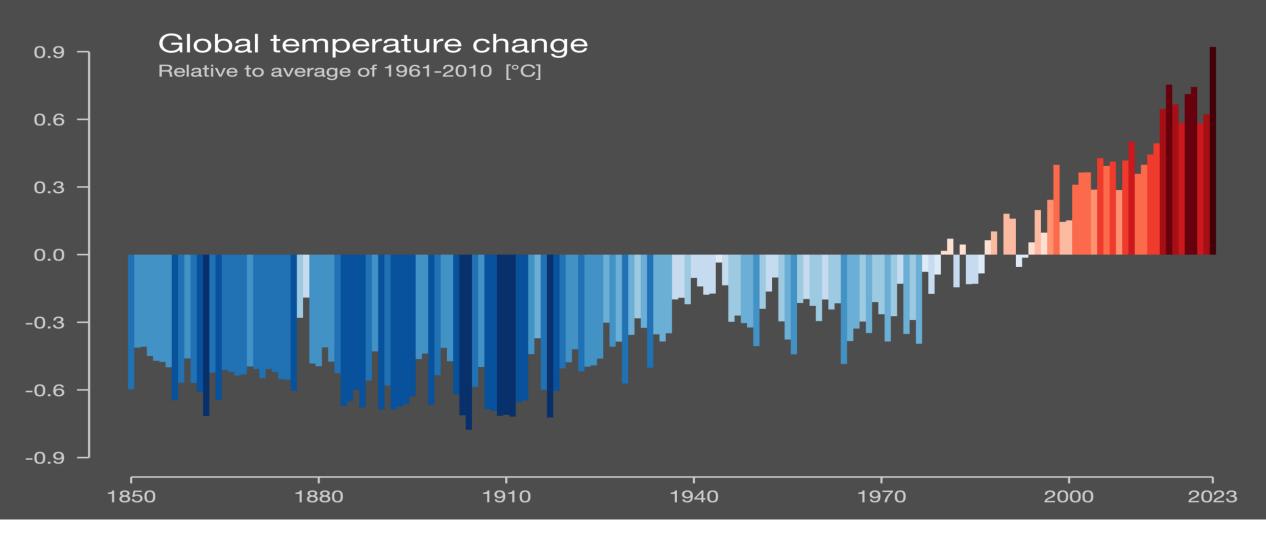

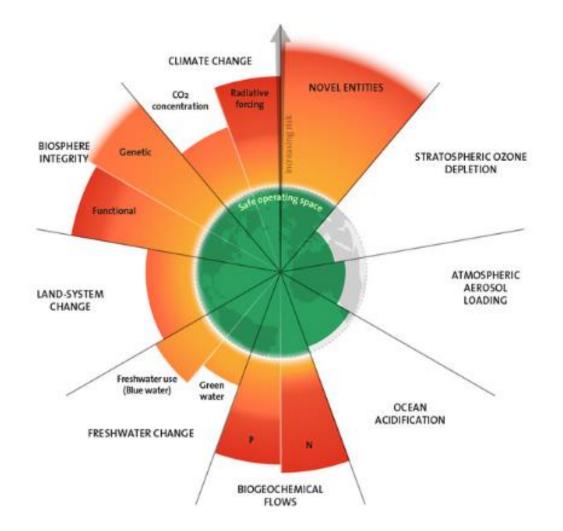
# Global temperature change

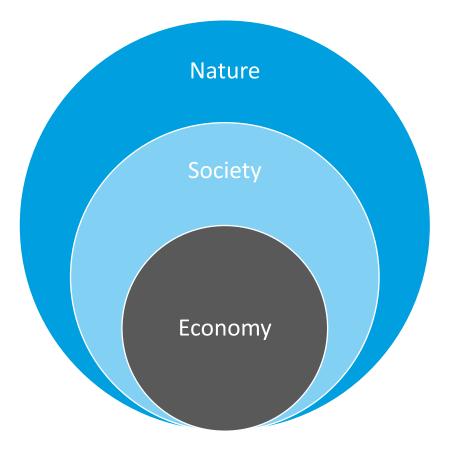
